WHEREAS, the RCMP report Missing and Murdered Aboriginal Women: A National Operational Overview released in May, 2014 by the RCMP on missing and murdered Indigenous women recorded that Indigenous women are over-represented among Canada's murdered and missing women and that the rate of victimization by acts of violence against Indigenous women and girls was "close to three times higher" than in the case of non-Indigenous women and girls; and,

WHEREAS, the unacceptable risk of violence that Indigenous women and girls in Canada face is attributable to the same factors that result in the disproportionately high and over representation of Indigenous children in the child welfare system; and,

WHEREAS, on November 12, 2014, the AMC Executive Council of Chiefs endorsed and supported through Resolution #14 Families First, a made in Manitoba approach to Missing and Murdered Indigenous Women and Girls (MMIWG) to create a recommended process for action; and

WHEREAS, the Truth and Reconciliation Report states "a devastating link between the large numbers of missing and murdered Aboriginal women and the many harmful background factors in their lives...many of which are part of the legacy of residential schools"; and,

WHEREAS, the AMC has developed a Manitoba approach that focuses first on families of Missing and Murdered Indigenous Women and Girls; and,

WHEREAS, the AMC Women's Committee tabled the *Families First Report* (2015) which outlines a Manitoba made approach to working with families of MMIWG and to work towards the protection of Indigenous Women.
