WHEREAS, the Chiefs in General Assembly by Resolution of April 21, 1994 directed that:

"Prior to finalizing and signing the Framework Agreement, a further General Assembly of Chiefs shall be held for the purpose of considering approval of the draft Agreements, Workplan, resources, other documentation arising and detailed next steps"; and

WHEREAS, a draft Framework Agreement has been presented to this Assembly which is subject to further amendment and to ratification by the Chiefs-in-Assembly and by Canada; and

WHEREAS, the draft Framework Agreement has been, and continues to be, negotiated by the Joint Working Group under the direction of the Chiefs' Executive Committee.

THEREFORE BE IT RESOLVED, that the Chiefs of Manitoba favour proceeding with the proposed project and direct that changes to the draft Framework Agreement of June 15, 1994 be negotiated consistent with the direction of this Assembly and be brought back to a Special General Assembly for consideration and ratification.
