WHEREAS Murray Morrisons' despicable attitude and action has severely strained ongoing negotiation and consultation between INAC and First Nation leaders:

WHEREAS Murray Morrison has shown no sensitivity whatsoever toward the plight of Indian people;

AND WHEREAS the action of Murray Morrison is tantamount to a breach of his fiduciary duty, and his obligation toward Indian people;

AND WHEREAS the action of Murray Morrison has breached his responsibility toward Indian people;

CARRIED

THEREFORE BE IT RESOLVED that the Director General of Indian Affairs terminate Mr. Morrison effective immediately, with no further involvement with Indian people whether it is direct or indirect.

SECONDED BY:

AND WHEREAS it is necessary to develop some strategies, plans of action, and processes with the goal of improving the housing conditions and concerns of First Nations;

AND WHEREAS a Chiefs Housing Committee has been formed as a result of the Chiefs Assembly in August 1988;

THEREFORE BE IT RESOLVED that the Chiefs Committee be given the task of developing strategies, action plans, and resolutions on behalf of Manitoba First Nations;

AND BE IT FURTHER RESOLVED that the Chiefs Housing Committee process their recommendations through the AMC executive council, and the executive will canvas First Nations on recommended format.

MANITOBA CHIEFS HOUSING CONFERENCE RESOLUTIONS

Subject: Funding Allocation / Formula Funding / Winter

Roads

MOVED BY:

Chief Tommy Weenusk Oxford House Band WHEREAS we the First Nations have been experiencing lack of consultation by the Department of Indian Affairs; and;

WHEREAS the Department of Indian Affairs have been making arbitrary decisions affecting all program funding; and

SECONDED BY:

Chief Alex Okemow God's Lake Narrows WHEREAS formula funding has been introduced and is being implemented by Indian Affairs; and;

WHEREAS we are feeling the adverse effects because of this method of allocating funding; and

WHEREAS the impact is really felt in the area of Capital Allocation; and

CARRIED

WHEREAS the Department of Indian Affairs have arbitrarily decided to use next fiscal years' capital funds for this years' winter roads construction and operation; and

WHEREAS this will have a negative impact on next year's capital allocation, especially for the bands that receive services via winter roads; and

WHEREAS the bands affected do not want this to happen, nor do they support it.

THEREFORE BE IT RESOLVED that

- (a) the AMC Executive Council and the Department of Indian Affairs review the Departments' method of funding allocation to Tribal Councils and Bands, and furthermore that the Department of Indian Affairs shall fund this whole process,
- (b) the Department of Indian Affairs consult and negotiate with each Tribal Council and Band prior to any change of funding allocation and/or decision to funding allocation,

the AMC Executive Council and the Department of Indian Affairs examine the impact the formula funding has on Tribal Council and Bands prior to next fiscal year,

- (d) the Department of Indian Affairs will not, and shall not, charge any capital expenditures for winter roads to next fiscal year's allocation, and
- (e) the Department of Indian Affairs shall find/obtain additional dollars to fund winter road construction and operation.
