WHEREAS the recent fire in northern Manitoba has further complicated and added hardship to the Dene way of life.

THEREFORE BE IT RESOLVED THAT both the Federal and Provincial Governments make available the financial assistance required by the Band members of Tadoule Lake to purchase the equipment they need to pursue their livelihoods;

BE IT FURTHER RESOLVED THAT grants and technical support be made available to the Band members of the Fort Churchill Band from the Manitoba Region Trappers' Association.

WHEREAS the existing airstrip is over 5,000 feet long and can be easily and cheaply upgraded to accommodate large transport and passenger aircraft;

WHEREAS the communities in the vicinity of God's River, as well as God's River itself, require a major airstrip in the region, complete with modern air guidance systems and safety features;

WHEREAS the Government of Manitoba budgetted \$350,000 to begin work on the airstrip during the summer of 1988 and subsequently in the new budget withdrew the \$350,000 for use on transportation facilities elsewhere;

WHEREAS the Government of Manitoba has failed to pay the God's River Band the sum of \$200,000 owed to the Band by the Province for costs incurred by the Band as a consequence of the Province's failure to properly and legally manage Crown Lands on which the aistrip serving the community is located;

WHEREAS the Government of Manitoba agreed, in March, 1988, to reimburse the Band for additional costs incurred by the Band;

WHEREAS negotiations between the Band and the government are becoming nothing more than a stalling technique by the government.

THEREFORE BE IT RESOLVED THAT the Assembly of Manitoba Chiefs assist the God's River Band to recover this debt and that this will be immediately conveyed to the government and the public via the mass media.

WHEREAS the Indian Birch Band has identified land which it is interested in investigating as a possible addition to its reserve, as described in Band Council Resolution dated August 24, 1989;

WHEREAS this land is currently administered by the Province of Manitoba.

THEREFORE BE IT RESOLVED THAT the Assembly of Manitoba Chiefs fully support the acquisition of this land as Reserve land for the Indian Birch Band;

BE IT FURTHER RESOLVED THAT Indian and Northern Affairs Canada act to expedite the acquisition of this land as quickly as possible, including making assertive representations to the Province of Manitoba on behalf of the Band.

WEHREAS this action would completely undermine the stated goal of discussion, collaboration, and consensus seeking;

WHEREAS the issues to be addressed are too critical and significant to be compressed into a four-month negotiation process.

THEREFORE BE IT RESOLVED THAT:

- The Minister of Indian Affairs affirm the Federal Government's commitment to a full and equal participation and negotiation process with First Nations;
- (2) The Minister of Indian Affairs assure the First Nations of Manitoba and give his undertaking that no changes will be made to the contribution agreements of the agencies for the 1990/91 fiscal year (with the exception of the normal process of amendments to increase contribution agreements to reflect actual expenditures and cost of living increases) unless these changes have been agreed to by negotiation and consensus;

- (3) Any changes in funding levels and/or categories will be made only after the full negotiation and consensus between First Nations and the Federal Government;
- (4) This shall in no way prejudice any negotiations which may be undertaken;
- (5) Any implementation of program and/or policy changes with respect to First Nations Child and Family Services will be made only with the full participation and consensus of the First Nations involved.

WHEREAS the <u>Indian Act</u> contradicts and impedes Indian selfgovernment and should be amended or replaced by new legislation based on, among other things, reaffirmation and implementation of the Treaties as may be desired by First Nations;

WHEREAS Indian and Northern Affairs Canada has embarked on a review of Lands, Revenues & Trusts and related matters under the Indian Act, with a view to changing and updating the legal framework which applies to Indian First Nations;

WHEREAS First Nations, under the Assembly of Manitoba Chiefs and other regional associations, have agreed and identified their own agenda that they will pursue regardless of the Lands, Revenues & Trusts Review, which at this time remains only one option for fundamental change desired by First Nations;

WHEREAS the Assembly of Manitoba Chiefs Executive Council has initiated its own process to inform First Nations and obtain their views on the Lands, Revenues & Trusts Review and has implemented approaches to effect this with funding support from Indian and Northern Affairs Canada.

THEREFORE BE IT RESOLVED THAT First Nations will not agree to any changes in the <u>Indian Act</u> or Lands, Revenues & Trusts policy or any new legislation or policies replacing it until they have been clearly informed and fully understand the implications arising therefrom;

BE IT FURTHER RESOLVED THAT the Assembly of Manitoba Chiefs process described in the October 30, 1989 paper titled, "AMC WORKPLAN AND COMMUNICATIONS STRATEGY ON THE MANITOBA LRT REVIEW" which process has already begun, continue to be implemented for those First Nations desiring access to this process;

BE IT FURTHER RESOLVED THAT any actions undertaken or contemplated by First Nations in pursuance of this resolution shall not be in any way interpreted as prejudicing the right of the peoples of First Nations to self-determination or the recognition and protection of their inherent right to self-government.

THEREFORE BE IT RESOLVED THAT the Assembly of Manitoba Chiefs support the position of the First Nations Confederacy in opposition to officials from Indian and Northern Affairs visiting member Bands until there is consultation between the Indian leadership of Manitoba and the Minister of Indian and Northern Affairs;

BE IT FURTHER RESOLVED THAT the Assembly of Manitoba Chiefs demand negotiations take place now on this new funding arrangement prior to Bands being forced into signing these arrangements in order for funds to flow in the new fiscal year.
