WHEREAS, the F.A.I. process was designed and developed by former and current First Nation leaders over a period of time; and

WHEREAS, the F.A.I. Memorandum of Understanding and Workplan was signed on December 7, 1994 in Winnipeg; and

WHEREAS, F.A.I. - M.O.U. and Workplan was based on Principles outlined in the M.O.U. under Section 5 [5.1 - 5.17]; and

WHEREAS, there appears to be second thoughts and apprehension about the F.A.I. process; and

WHEREAS, there are also some Manitoba First Nations who believe that the F.A.I. process will protect our treaties, provide a modern day interpretation of those historical and sacred agreements made by our forefathers while giving full recognition to their original spirit and intent; and

WHEREAS, the Manitoba First nations feel there was a breach of the F.A.I. agreement by the Minister of Indian Affairs, Ron Irwin, through his initiative to amend portions of the Indian Act, when in fact we have a specific Section [5.5] in the F.A.I. agreement that outline for Manitoba First Nations the process we are to use to amend or reject the Indian Act as it applies to First Nations in Manitoba.

**RE:** NORTH AMERICAN INDIGENOUS GAMES

WHEREAS, at a recent North American Indigenous Games (N.A.I.G.) council meeting in Fargo, North Dakota, the 1997 N.A.I.G. presented a financial report that indicated a \$1 million cut to their operational budget; and

WHEREAS, this is a direct result of the Federal Government's decision to cut the funds down to \$650,000; and

WHEREAS, this will also reduce the Provincial Government of British Columbia's matching allocation and expected corporate sponsorship which will result in the original level of \$3.8 million now cut to \$1.7 million; and

WHEREAS, this will have serious impact on the successful operation of the North American Indigenous Games.

THEREFORE BE IT RESOLVED, that the Assembly of Manitoba Chiefs demand that the Federal Government support First Nations Youth Initiatives and reinstate the funding to the North Indigenous Games Council.

WHEREAS, the Keewatin Tribal Council has requested that Medical Services Branch refer patients to the Thompson General Hospital only in critical situations and all other patients to Winnipeg.

THEREFORE BE IT RESOLVED, that the Assembly of Manitoba Chiefs support the Keewatin Tribal Council in their efforts to pursue the improvement of health service delivery provided by the Thompson General Hospital or in exploring other options such as referrals to the Norway House Hospital for the provision of health service delivery for their people.

WHEREAS, in 1992, the First Nations Personal Care Homes was mandated by a resolution from the Assembly of Manitoba Chiefs to develop standards for First Nations Personal Care Homes onreserves; and

WHEREAS, the Manitoba First Nations Personal Care Homes have collectively developed Program, Operational, and Funding Standards for Manitoba First Nations Personal Care Homes on-reserves; and

WHEREAS, the Program, Operational, and Funding Standards will ensure a consistent optimum level of services providing a holistic/wellness model of care to First Nations elders in Personal Care Homes; and

WHEREAS, these standards represent a funding base as well as an accountability mechanism for funding agencies; and

WHEREAS, there is a jurisdictional disagreement between I.N.A.C., the Province of Manitoba and Health Canada as to the funding of First Nations Personal Care Homes on-reserves.

#### THEREFORE BE IT RESOLVED:

1. That the Assembly of Manitoba Chiefs mandate the Manitoba First Nations Personal Care Homes Network to act in an advisory capacity on issues relating to Care Homes on-reserves; and

FURTHER BE IT RESOLVED, that the Assembly of Manitoba Chiefs lend the required political support to a coalition of Manitoba aboriginal businesses to take a lead role in ensuring the implementation of the procurement policy.
